Conditions of Membership

I understand that this is a continuous membership payment plan. I may revoke my authorization at any time in writing, or by phone subject to providing notice of fourteen (14) days. To obtain a sample cancellation form, or for more information on your right to cancel a preauthorized payment agreement, contact your financial institution or visit www.cdnpay.ca. A cancellation form or written notice is also available at the front desk of any YMCA Regina location.

The YMCA Regina may, at its discretion, adjust the bi-weekly rate it charges for memberships. I understand that I will receive at least 30 days notice prior to any such change.

Should my bank for any reason not honour any pre-authorized payment, I understand that I am still responsible for the payment, plus a service charge of no more than \$20.00. This is in addition to any service fees my bank may make. The YMCA Regina will automatically resubmit the payment, plus the service charge, along with my next bi-weekly payment. If the subsequent payment is also not honoured, the YMCA Regina will terminate my membership and future scheduled payments until I have brought all payments up to date.

You have certain recourse rights if any debit does not comply with this agreement. For example, you have the right to receive reimbursement for any debit that is not authorized or is not consistent with this pre-authorized payment agreement. To obtain more information on your rights, contact your financial institution or visit www.cdnpay.ca.

All members are required to present a valid membership card for identification when using the YMCA Regina facilities and/or participating in programs. If for any reason members are unable to present a membership card they will be required to present photo identification. Membership cards are not transferrable; remain the property of the YMCA Regina; and must be returned to the YMCA Regina upon request.

Terms and conditions of membership with the YMCA of Regina are defined in the Membership Information Guide and are subject to change. Memberships continue indefinitely unless members provide written notice of cancellation, or the YMCA of Regina terminates the membership. Fully paid Annual and Assisted memberships must be renewed after expiry by visiting any YMCA Regina location.

I understand that I will be automatically transferred into a new membership category on my birthday if I am eligible, in which event dues may increase or decrease. In the event of any other qualifying event that changes the category of membership for which I am eligible, I agree to notify the YMCA Regina on or before the first day of the month following the month in which such event occurs.

I consent to receiving the YMCA of Regina's newsletter and other messages regarding the YMCA of Regina's products and services. I may withdraw my consent at any time using the Opt Out functions of the web service hosting such information, or by contacting the YMCA of Regina at (306) 757-9622.

The YMCA of Regina reserves the right to close areas of the building in order to upgrade and/or maintain the facilities and equipment to better serve the needs of all our members. No refunds for membership fees or program fees will be issued due to such closures.

A joiner fee of \$65.00 CAD will be applied to all new accounts (Youth memberships excluded from fee). If an active membership has been held within the last 4 calendar months this joiner fee may be waived at the discretion of the YMCA of Regina. The joiner fee is non-refundable.

Liability Waiver

I understand that the YMCA of Regina assumes no responsibility for injuries or illnesses which I, my spouse/partner, or my minor children or any other person may sustain as a result of my/their physical condition, this membership, my/their use of any facility or my/their participating in any activities, program, exercise, or the use of any equipment (collectively, "Activities"). I expressly acknowledge on behalf of myself, my spouse/partner, my minor children and our heirs that I assume the risk for any and all injuries, illnesses, death, loss or damage which may result from any of the foregoing. I hereby release and discharge the YMCA of Regina, its agents, servants, and employees from any and all claims for injury, illness, death, loss or damage which I, my spouse/partner, or minor children may suffer as a result of my/their physical condition, this membership, the use of any facility or participation in any Activities. In the event I, my spouse/partner or minor children bring any guest to any YMCA of Regina facility or Activity, I also agree to be responsible for ensuring that such guests adhere to the rules and policies of the YMCA of Regina and to inform them that they assume all liability for injuries, illness, death, loss or damage which may result from participating in any activities programs, exercise or the use of any equipment.

I understand that the YMCA of Regina is not responsible for personal property lost or stolen while members and/or program participants are using YMCA facilities or are on YMCA premises.

I give my permission to the YMCA of Regina to use indefinitely, without limitation or obligation, photographs, film, footage, or tape recordings which may include my, my spouse or minor children's image or voice for purposes of promoting or interpreting YMCA programs.
